

Considering that the use of services, contact or cooperation with MLP Group S.A. may involve the processing of your personal data (“Personal Data”, “Data”), please familiarize yourself with the following information.

1. The **Controller your Personal Data** is MLP Group S.A. with its registered office at the following address: ul. 3 Maja 8, 05-800 Pruszków (“MLP”).
2. **Your Personal Data will be processed while maintaining appropriate security measures** that comply with the law and the best practices of information security management.
3. **Your Personal Data will be processed for the following purposes:**
  - provision of services involving the leasing of storage, manufacturing and office space,
  - performance of visual monitoring (if applicable),
  - performance of investment and development activities,
  - settlement and invoicing of services and utilities,
  - contact related to any sent inquiries,
  - conduct of the complaint procedure (if applicable),
  - marketing purposes, if the legal basis for the processing involves permitted and legally justified interests of the controller of personal data – Article 6(1)(f) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (“GDPR”).
  - In addition, your Personal Data may be used for statistical purposes if justified by legally permitted and justified interest of the personal data controller (Article 6(1)(f) of the GDPR).
4. **You provide your Personal Data on a voluntary basis**, yet they may be indispensable for the achievement of some of the purposes of their processing.
5. **Your Personal Data will be stored only for the period necessary to pursue the above purposes** and, after these have been achieved, for a period required by the provisions of law imposed on the data controller, including (i) provisions on civil-law liability for the proper performance of obligations by the parties and (ii) tax laws.
6. **Recipients of your Personal Data** may be appropriate employees of Miejskie Zakłady Oczyszczania [Municipal Waste Treatment Plant] in Pruszków to the extent that it may be required to perform the duties associated with the provision of parking services, including their settlement and invoicing. **Furthermore, your Personal Data may be provided to other entities in compliance with Article 28 of the GDPR** if their cooperation with MLP is justified by the processing purposes described above or by the storage of Data (e.g. to entities providing postal, courier, banking, consulting, financial, accounting, tax, auditing or legal services or to entities providing such IT services as hosting or maintenance of IT systems and software), including entities supplying and maintaining parking systems or the landlord of the land on which the Parking Lot is located (if applicable). For marketing activities, Data recipients may be selected MLP employees, advertising agencies, entities providing marketing services (including selected employees and partners) to the extent that they participate in the marketing activities.
7. **You have the right** of access to your Personal Data as well as the right of rectification and deletion, the right to restrict their processing, the right to object to the processing of your Data due to your special situation or for direct marketing purposes as well as the right to withdraw your consent to the processing of your Data at any time without affecting the lawfulness of the processing performed until then.
8. **If you think that any personal data protection regulations have been breached**, you have the right to file a complaint with the supervisory authority in charge of personal data protection in the Member State of your habitual residence, place of work or place of the alleged breach.
9. **Your Personal Data are processed on the basis of the following laws:** Articles 6(1)(b), (c) and (f) of the GDPR.
